Petition must be completed by the man proclaiming that he is the father of the child.

Child must be a resident of Chambers County

Valid Photo ID (Driver License or Non-driver ID that has not expired) and Social Security Card for the Petitioner and Mother of the child. *Names on the Photo ID and Social Security Cards must match exactly.*

If the Mother's name that is on the Birth Certificate is different from current name we will need copy of the documentation that shows the reason why – Marriage Certificate, Divorce Decree granting Name Change, Order Granting Legal Name Change, etc.
